AS A CHARTER MEMBER OF THE HUMAN MILK BANKING ASSOCIATION OF NORTH AMERICA (HMBANA), THE ORGANIZATION'S STANDARDS OF PROCESSING DONATED BREAST MILK ARE THE BASIS OF OPERATION FOR ALL MILK BANKING ORGANIZATIONS.
